Announcement of public selection based on qualifications and interview for no. 1 research grant in the field of “Study and analysis of techniques and processes for the transfer of scientific and technological knowledge within the activities of the HORIZON-RIA project “CO2SITE”, aimed at the development of a European atlas of potential geological CO₂ storage sites” for the Geophysics Section of the National Institute of Oceanography and Applied Geophysics – OGS.

Introduction

The National Institute of Oceanography and Applied Geophysics - OGS, is holding a public selection based on qualifications and interviews for the award of no. 1 research grant for the Geophysics Section of the National Institute of Oceanography and Applied Geophysics – OGS.

The grant cannot be combined with any other type of grant or scholarship, nor with fellowships or allowances of a similar nature. The grant is not compatible with permanent or fixed-term private or public employment, with the exception of unpaid leave arranged with the employer.

OGS cannot pay any additional compensation to research grant holders for any reason, and the activities carried out by grant holders shall under no circumstances constitute employment.

The research grant does not entitle the holder to social security benefits, nor shall it be taken into account for the purposes of legal or economic career progression or for pension recognition.

Art. 1 – Positions for selection

A public selection based on qualifications and interviews is open to award no. 1 research grant in the field of “Study and analysis of techniques and processes for the transfer of scientific and technological knowledge within the activities of the HORIZON-RIA project “CO2SITE”, aimed at the development of a European atlas of potential geological CO₂ storage sites” for the Geophysics Section of the National Institute of Oceanography and Applied Geophysics – OGS.

The research fellowship is aimed at carrying out research and training activities focused on the study, analysis and enhancement of the scientific and technological results produced within the research activities of the European project CO2SITE, dedicated to the development of a European atlas of potential geological CO₂ storage sites. The training programme includes applied research activities on processes for the transfer, valorisation and dissemination of scientific and technological knowledge, with particular reference to the topics of geological CO₂ storage and their role within the context of European policies for climate change mitigation and the development of infrastructures supporting the energy transition. The activities will be carried out through qualitative and quantitative analysis methodologies, including the collection, systematisation and interpretation of data related to the scientific results of the project and to the modalities through which knowledge is transferred to institutional, industrial and scientific stakeholders.

In particular, the activities will include:

- analysis of the most effective strategies for the valorisation and transfer of research results, in order to promote their effective application within the scientific community, industrial stakeholders and public institutions;

- study of the dynamics of interaction between scientific research, stakeholders and society, with reference to the topics of energy transition and climate change mitigation;
- design and implementation of surveys, questionnaires and statistical data collection activities aimed at analysing the level of knowledge, perception and engagement of different stakeholder groups with respect to the topics of geological CO₂ storage;
- analysis and interpretation of the collected data, also through the use of statistical tools, with the aim of contributing to the definition of effective strategies for the transfer and valorisation of research results.

Within the framework of the research and training activities described above, the fellow may also collaborate in the development of tools and initiatives aimed at disseminating and enhancing the activities and results of the project, including:

- preparation of information materials and digital content related to the research results;
- support to the management and updating of the project information tools (website and communication channels);
- collaboration in the organisation of workshops, scientific events and discussion opportunities with institutional, industrial and scientific stakeholders;
- development of innovative tools to support the understanding and promotion of the project topics among different audiences.

Art. 2 – Duration and amount of the Research Grant

The grant lasts for 6 months and may be renewed.

Research grants may be renewed only once, for a period of no less than six months, up to a maximum of 24 months. Renewal is proposed by the Director of the structure (Section or Centre) where the grant holder carries out their activities, at the request of the scientific supervisor and subject to a positive evaluation of the activity report as referred to in Article 11 of this call.

The grant salary (6 months), net of charges payable by OGS, is set at € 10.054,85 and is paid in monthly instalments.

The research grant holder is entitled to reimbursement of mission expenses (travel, board and lodging), in accordance with the procedures and limits set by the OGS Mission Regulations, if required to carry out activities outside the regular place of research.

Art. 3 – Admission Requirements



To participate in the selection process, candidates must:

- a. Be no older than 35 at the time of application;
- b. Hold a university degree in scientific disciplines awarded in accordance with the regulations in force prior to the reform pursuant to Ministerial Decree 509/99 or a Master's degree in scientific disciplines obtained from an Italian or foreign university;
- c. Have an excellent knowledge of English (both written and spoken) for drafting articles and presenting results in international contexts;
- d. Have knowledge of the main IT applications;

Citizens of any European Union Member State and third-country nationals holding a degree obtained under the regulations prior to Ministerial Decree No. 509/1999 (old system), a Specialist Degree, or a Master's Degree awarded by Italian or foreign universities, as well as any additional requirements specified in the call for applications are eligible to take part in the selection.

For candidates with qualifications obtained abroad, the scientific relevance of the degree, solely for admission purposes, will be evaluated and recognized by the Selection Committee.

All admission requirements must be met by the application deadline published on the official OGS website.

Assessment of the requirements listed under points c), d) and e) shall be entrusted to the sole and final judgment of the Selection Committee referred to in Article 6, during the oral examination.

Art. 4 – Application form: terms and conditions

The application form to participate in the call, drawn up on plain paper using the form provided (Attachment A) and signed by the applicant with either a handwritten or a digital signature pursuant to current regulations, must be received no later than 11:59 p.m. on the 30th day following the date of publication of this notice on the OGS website <https://www.ogs.it/it/concorsi>, namely by the published deadline, exclusively via the applicant's personal Certified Email (PEC), in compliance with applicable regulations, to the following PEC address: ogs@pec.it, specifying in the subject line:

Only and exclusively for foreign applicants and Italian citizens residing abroad, in the event they are unable to submit their application via PEC, may the application form to participate in the selection (Attachment A) also be submitted via ordinary personal email to the following address: protocollo@ogs.it.

If the maximum limit of 30 MB per individual PEC message is exceeded, applicants should send multiple submissions as needed, clearly indicating the submission number in the subject line (e.g. Call 05/2026 – Surname Name, First Name – Research Grant – submission no. X of Y).

Files sent in ".zip" folders will not be accepted.

No other methods of submission or formats will be accepted, under penalty of exclusion.

The application must be received no later than 11:59 PM on the deadline date indicated in this call.

In the application, the applicant must declare the following information under his/her own responsibility,:

- Surname and name;
- Place and date of birth;
- Residence (address, city, province/state, zip code, country);
- Nationality;
- That they have not been convicted or found guilty of any criminal offence, specifying, if not, which convictions they have had;
- To be in possession of the required qualifications, specifying date, place of issue, final mark;
- To be in possession of the further requisites as per art. 3 of this Call;
- The chosen address for the selection procedure.

The declarations made in the application shall be considered as self-certifications or affidavits pursuant to Articles 46 and 47 of Presidential Decree No. 445 of 28 December 2000, as amended, and are submitted under the applicant's own responsibility. False declarations and forged documentation entail criminal liability pursuant to Article 76 of Presidential Decree No. 445/2000, as well as the consequences set out in Article 75 of the same Decree.

OGS reserves the right to verify the validity of the applications and the possession of the required qualifications at any stage of the selection process.

The candidate must enclose with the application form the following documents:

1. A Curriculum Vitae et Studiorum (possibly in European format) written either in Italian or English, dated and signed with handwritten or digital signature; in the CV the applicant must include all the useful information for the evaluation. At the bottom of the curriculum, the following declarations should be included:

o "The information contained in this curriculum vitae is made under the personal responsibility of the undersigned in accordance with Articles 46 and 47 of Presidential Decree no. 445 of 28.12.2000, aware of the criminal liability envisaged in Article 76 of the same Presidential Decree no. 445 of 28.12.2000, for the hypotheses of falsity in deeds and mendacious statements";

o "I authorize the processing of my personal data in the curriculum vitae in accordance with Legislative Decree no. 196 of June 30, 2003 "Personal Data Protection Code " and Article 13 of the GDPR (EU Regulation 2016/679)".

2. Qualifications and documents that the applicant considers useful to submit to the Selection Board; the qualifications and documents must be presented with a declaration in lieu of

certification or affidavit pursuant to Articles 46 and 47 of Presidential Decree no. 445 of 28.12.2000;

3. A photocopy of a valid Identity Document.

The application should indicate any possible need for aids or assistance during the interview in relation to the specific certified disability.

Art. 5 – Exclusions

Exclusions from the selection process, for whatever reason, may be ordered, at any moment during the selection procedure, by decision of the Director General on the indication and proposal of the person in charge of the procedure and/or the Examining Board pursuant to art. 6 below.

Exclusions will be communicated to the persons concerned within 5 days of the adoption of the relevant measure.

Art. 6 – Selection Board

The Selection Board is appointed by the OGS Director General and comprises three experts in the subjects specified in the call for applications, including the scientific Tutor. Where the experts are selected from among the OGS personnel, they must belong to different organizational units (Sections or Centres). The role of secretary shall be entrusted to the youngest member of the Selection Board.

The Selection Board, at its constituent meeting, must declare the absence of any grounds for incompatibility and any conflict of interest among its members, and subsequently proceed to establish the detailed criteria and methods for the evaluation of qualifications and the interview.

After reviewing the list of applicants, the Board members must again declare that no grounds for incompatibility or conflict of interest exist with regard to the candidates.

The Selection Board may also convene remotely, provided that the security and traceability of communications during meetings are ensured.

The Board shall complete the selection procedure within six months from the date of its first meeting. Failure to comply with this deadline must be collectively justified by the Selection Board through a reasoned report to be submitted to the Director General (Art. 11 – Presidential Decree No. 487/1994).

Art. 7 – Evaluation of qualifications, interview, and ranking list

The selection is based on qualifications and interview.

The Selection Board can assign up to 100 points, divided as follows:

- 30 points for the evaluation of the qualifications;
- 70 points for the interview.

QUALIFICATIONS (max 30 points out of 100)

The Selection Board preliminary adopts the criteria and the parameters it intends to follow, with specific reference to the characteristics of the research project.

To evaluate qualifications, the Selection Board has a maximum of 30 points to allocate according to the following list:

- University Degree final mark and relevance to the subject of the call;
- Postgraduate specialization and advanced training courses (e.g. first- and second-level Master's degrees), both in Italy and abroad, in the field covered by the call;
- Previous collaborations with public or private organizations, based on contracts, fellowships or assignments, both in Italy and abroad;
- Documented training courses in scientific communication and dissemination and/or in the production of multimedia content and materials Scientific and/or technological activities and publications;
- Proven experience in the use of digital communication tools (websites, graphics, videos, social media, etc.);
- Previous knowledge and experience in environmental issues.

The results of the evaluation of qualifications must be communicated to the candidates by publication on the OGS institutional website prior to the interview.

INTERVIEW (max 70 points out of 100)

The date of the interview shall be communicated at least 15 days before the scheduled date.

The interview may be conducted in either Italian or English.

The interview may be conducted via videoconference, using digital and IT tools, with technical measures in place to guarantee its public nature, participant identification, and communication security.

The Selection Board reserves the right to publish any detailed instructions regarding the conduct of the interview in advance on the institutional website.

The interview will focus on the topics covered by this call for applications as referred to in Article 1, on any relevant experience acquired, and on any activities carried out.

Candidates must present a valid identification document to attend the interview.

Candidates who do not provide a valid identification document or who present expired documents will not be allowed to participate in the interview.

Candidates who do not attend the interview, or, in the case of a remote interview, fail to connect according to the procedures specified by OGS, will forfeit all rights to participation and will be declared disqualified from the selection process.

The selection process is considered successfully passed with a minimum overall score (qualifications + interview) of 60 points out of 100.

At the conclusion of its work, the Selection Board shall compile a merit ranking in descending order based on the total score obtained by the candidates, resulting from the evaluation of qualifications and the interview, and shall submit the records to the Directorate for Human Resources Management – Recruitment and External Personnel Office for publication on the OGS website at <https://www.ogs.it/it/concorsi>.

Publication shall constitute official notification to all intents and purposes.

Art. 8 – Final ranking

The Director General, once verified the formal validity of the documents transmitted to the Selection Board, shall approve with his/her own provision the ranking list and appoints the grant winner.

In the case of equal scores, preference shall be given to the younger candidate.

In order to ensure transparency in this selection procedure, the merit ranking and the final ranking — to which any preferential titles provided for in the call are applied — shall be published simultaneously on the OGS website: <https://www.ogs.it/it/concorsi>.

Should the selected candidate decline the offer, the final ranking shall be used to award the grant to the next eligible candidate. Similarly, in the event of an early termination of the grant, the ranking may be used to assign the remaining duration to another eligible candidate, provided the remaining period is not less than six months.

The ranking is valid exclusively for the research project specified in this call and may not be used to award grants related to other projects or supervised by a different tutor.

The principle of minimisation of personal data shall remain fully applicable.

Art. 9 – Awarding of the grant

The Director General of OGS, in compliance with the applicable regulations and having verified the formal regularity of the documentation submitted by the Selection Board, shall approve the outcome of the selection procedure by means of a specific decree and award the research grant to the selected candidate by signing a dedicated contract.

The selected candidate will receive formal notification of the outcome of the selection process and must submit a declaration of acceptance of the grant within a non-extendable deadline of 15 days from the date of receipt of said notification.

Upon accepting the grant, the selected candidate shall submit a self-declaration in lieu of affidavit certifying the absence of any grounds for incompatibility and shall also undertake to promptly communicate any subsequent changes relevant to the signing of the contract that defines the terms and activities covered by the research grant.

Individuals who have family ties or kinship up to the fourth degree with the tutor, the Director, or any staff member of the structure (Section or Centre) where the activity will take place, are not eligible to participate in the grant assignment procedure.

The research grant cannot be combined with any other grant awarded for any reason, nor with employment contracts or similar forms of financial support. It is also incompatible with employee work.

The grant is incompatible with self-employed activities, including para-subordinate collaborations, except for occasional self-employment activities, which must be authorised in advance by both the tutor and the Director General, and provided that such activities do not create conflicts of interest or prejudice OGS in relation to the grant activities.

The grant is compatible with the attendance of PhD programmes or postgraduate specialisation courses, in Italy or abroad, provided that no fellowships or research grants are awarded as part of those programmes.

Art. 10 – Carrying out the study activity

The grant holder shall carry out the study and research activities independently, without any dependence or predetermined working hours restrictions, in compliance with the approved programme and the guidance provided by the scientific tutor.

Art. 11 – Obligations of the grant holder and evaluation of the research activity

The grant holder shall carry out the research activity for which the grant is intended, in accordance with the programme defined by the scientific tutor and under the tutor's supervision.

At the end of the activity period, the grant holder shall submit a final report to the Director of the host structure (Section or Centre) detailing the activities performed and the scientific results achieved, accompanied by the tutor's assessment. This report must indicate the projects in which the grant holder has been involved, as well as any publications or other research outputs produced during the period of grant award.

All technical, scientific, and administrative data and information acquired by the grant holder in the course of the activity shall be considered confidential and may not be used for purposes other than those officially related to the grant.

Regarding the protection of intellectual property rights on the results or outputs developed during the activity, reference should be made to the OGS Regulation on patents and intellectual property protection.

The grant holder is required to comply with the OGS Regulations, safety regulations, the code of conduct, and the internal organisational rules of the structure (Section or Centre) where the activity is carried out.

Art. 12 – Personal data management

In accordance with Article 13 of the EU General Data Protection Regulation (Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016, or GDPR), candidates are informed that treatment of their personal data, provided by applying to this selection or to this end collected by the National Institute of Oceanography and Applied Geophysics – OGS, is carried out solely for the purpose of managing the selection procedure and will be handled by the personnel in charge of the process, including the members of the Selection Board.
